# These Sidewalks Are For Walking (Not For Ducking, Bobbing, Or Weaving)

If you have trees, shrubs, or bushes on your property that are adjacent to sidewalks please be sure that your plants are not obstructing the sidewalk. It is the homeowner's responsibility to keep the sidewalks clear. What does that mean? Imagine two walls extending straight up from the sides of the sidewalk joined by a flat roof 7 feet above the sidewalk. This volume should not have anything in it besides air and pedestrians. If it does for the sidewalks that border your property, please have the encroaching plants trimmed back.
