

## **Sunwest HOA Fees**

2<sup>nd</sup> quarter HOA fees are due April 1st. There is a grace period, but if dues are not received within 30 days of the due date a \$25 late fee is charged to the homeowner's account. Delinquent accounts also accrue interest charges of 18%, so it pays to get your payments in on time.

# **Hide Your Trash Cans**

Please remember that trash cans must be stored out of sight to keep our neighborhood looking great, for example in your backyard or garage. If trash cans or recycling containers are visible from the street on non-pickup days, you'll get a notice from the property management company.

# Sand Wasps & Playgrounds

As the weather warms up, the likelihood of sand wasps increases. Sand wasps are about an inch long, and live in burrows tunneled in sandy areas. They look menacing, but are unlikely to sting. Although they're considered beneficial insects because they help control other insects,



including flies, they make our playgrounds must less attractive for our kids. If you see sand wasps in our playgrounds, email the board and we'll work to solve the problem.
