Sunwest HOA Fees Due January 1st

1st quarter HOA fees are due January 1st. There is a grace period, but if dues are not received within 30 days of the due date a \$25 late fee is charged to the homeowner's account. Delinquent accounts also accrue interest charges of 18%, so it pays to get your payments in on time. By the way, the Sunwest HOA Board is keeping the 2018 HOA fees unchanged from 2017 at \$140 per quarter.

Homeowners are reminded to call 911 in the event of an emergency. To report barking dogs, vandalism or a crime in progress (non-emergency) call police dispatch at 303-441-4444. To report Town of Erie code violations, or other police business call Erie PD at 303-926-2800 during normal business hours.

The Town of Erie and Sunwest HOA require dogs to be on a leash when they are not inside the house or a fenced-in yard. This applies to the unfenced front yard also.

The Town of Erie Police Department wishes to remind residents of Sunwest that public consumption of marijuana is still illegal. Please be advised smoking pot outside the house where smoke can drift into public spaces or neighbor's yards is considered public consumption by Erie PD.

Reduce, Reuse, Recycle

Recycling is a wonderful thing. But not so much when your neighbor's recycling ends up in your yard. Erie has a great climate, but it also has gusty winds that can blow the recycling out of our baskets and all over the neighborhood. Please be mindful of those particularly windy days when it is better to keep the recycling inside until the morning of the collection.

Most dog owners in Sunwest are responsible and pick up after their dog. Unfortunately, there are still a few bad apples that let their dogs roam the neighborhood and poop in their neighbor's yards. Snow Removal Reminder

The Town of Erie municipal code and Sunwest HOA CC&Rs require that snow and ice be removed from the sidewalks within 24 hours after snowfall. MSI will be sending out violation notices for un-shoveled sidewalks.

Holiday Decorations Reminder

Sunwest HOA allows holiday decorations to be displayed up to one month before, and up to one month after, the holiday. Be sure to have your decorations put away by then to avoid that friendly reminder letter from MSI.
