#### 4. Sunwest HOA 2011 Budget.

Sandalphon handed out revised copies of the 2011 Budget that were updated to show the actual costs for 2011 contracts that were not previously available. The current 2011 HOA budget is posted on the Web site. The good news is that significantly reduced monthly fees for property management will

result in faster growth of the required reserve fund, and may allow for further HOA fee reductions in the future. The 2011 quarterly fees are set at \$140, which is a reduction from the \$145 in 2010. Sandalphon moved to approve the 2011 Budget. Approved unanimously.
